**ART. 2** "The Armenian Arts Foundation" announces the call for applications to the collective exhibition of contemporary art entitled "Emozioni senza Frontiere" as an integration of the declared project.

**ART. 3** Artists of any nationality and religion can participate at the call, without age limits, operating in any artistic and creative field. Are allowed all the artistic techniques related to painting, sculpture, photography, digital works and/or mixed technique genres.

**ART. 4** Format of the artworks: Size maximum 160x100 cm for painting, photography, digital works and/or mixed technique genres. Size maximum 100x60x40 cm for sculptures. The artworks will be provided with adequate hooks and without glass.

**ART. 5** Every Artist can participate in the selection phase with a maximum of 5 (five) works, among which will be chosen 1 (one) work to be shown in the exhibition. For the selections, send photographies of the works in 18x24 digital format with a minimum resolution of 72 dpi.

**ART. 6** The photos with the complete presentation with: title of the single wok proposed, size of each work, name and surname of the author, technique, material used and artistic curriculum vitae, should be sent, no later than May 15, 2019\*, to the email address <u>emozioniinmostra@gmail.com</u>. **\*TERMS EXTENDED TO 14 JUNE 2019** 

**ART. 7** The artist's proposal can take place also signed by art galleries and associations/foundations of cultural and artistic promotion.

**ART. 8** To every selected artist will be guaranteed the following services:

- planning and realization of the paper catalog of the collective exhibition of contemporary art "EMOZIONI";
- exhibition of the work at Castel dell'Ovo in Naples from the 29 of August to the 9 of September 2019;
- general and secretarial organization;
- communication and press office;
- setting up and dismantling in Castel dell'Ovo in Naples.

**ART 9** The selected work must be received by the date that will be communicated in the next month of July c/o the headquarters of the Exhibition.

The work must be collected on 10 September 2019.

**ART. 11** The shipment of the works is charged to the participants; if it will be them who will deliver the piece on site, need to agree on a date and time in advance.

**ART. 12** The artist exempts the organizers of the exhibition from any civil or criminal liability for losses or damage to the works during the transit phases and in the entire phase of opening to the public of the exhibition

with automatic waiver of damages and compensation action against the institution organizer, of the Foundation and of the other exhibitors.

**ART. 13** The insurance coverage of the works is charged to the Artist or with written indication of resignation from the coverage itself.

**ART. 14** The application to participate filled in all of its parts, signed and scanned must sent by email to the following address: <u>emozioniinmostra@gmail.com</u> indicating in the subject "Participation to the collective exhibition of contemporary art "**EMOZIONI**".

**ART. 15** The selected artists are not bound to be present for the entire exhibition period; it is appropriate a presence both for the vernissage and for the day of closing to the public.

**ART. 16** The selected artists authorize the organizers to use the reproduction photographic documentation of the works free of charge for the promotion and presentation phases of the project; the works will be reproduced both in the paper catalog and in the various online formats related to the event.

**ART. 17** "**The Armenian Fine Arts Foundation**" reserves the right to change the date of the event exclusively for reasons derived from causes of force majeure.

**ART. 18** The Artist, having read the present announcement, is divided into 18 points.
